

Under Federal, State and Local law, employers are required to provide reasonable accommodations to individuals with disabilities. Generally, reasonable accommodations enable those with disabilities to apply for a position or to perform the essential functions of their job. Reasonable accommodations may include:

- Restructuring job duties;
- Enhancing accessibility of facilities;
- Providing additional or modified equipment;
- Changing policies;
- Reassignment to another job;
- Modifying schedules;
- Working from home, and;
- Providing unpaid leave.

However, if an accommodation would cause an "undue hardship" to the employer or if the individual cannot perform the essential functions of the job, no reasonable accommodation is required. One of the many ways that companies can find themselves in violation of these laws is to deny accommodations without engaging in an interactive process with the disabled individual. In many cases, simple accommodations can be offered that allow an individual to perform their job duties and satisfy an employer's legal requirements. In addition to accommodating disabilities, employers must also provide reasonable accommodations for pregnant employees and for an individual's religious beliefs.
